BY-LAWS OF THE
WYONG GOLF CLUB LIMITED

1. These By-Laws are subject to revision and alteration at the discretion of the Board. They are governed by and shall be read in conjunction with the Club's Constitution.
2. Any By-Laws made under the Constitution or any alterations to or repeal of any such By-Law shall come into force and have full effect and authority and be binding upon members of the Club on being posted on the Club Notice Board or Website.

MEMBERSHIP

(A) ELIGIBILITY

Any membership application aligned with a Class of Membership in (B) below, shall be eligible for election to membership of the Club provided all fees and charges prescribed by the Board have been duly paid.

(B) VARIOUS CLASSES OF MEMBERSHIP

i. 7 Day Playing Members

Persons who have attained the age of eighteen (18) years and who are elected as 7 day Playing Members or transferred by the Board from another class of full membership to 7 day Playing membership of the Club. Entitles members to 7-Day access to the golf course, facilities, competitions, honour board events and Golfink.

ii. 6 Day Playing Members

Persons who have attained the age of eighteen (18) years and who are elected as 6 Day Playing Members or transferred by the Board from another class of Full membership to 6 Day Playing membership of the Club. Entitles members to 6-day access (excludes Saturday) to the golf course, facilities, competitions and Golfink.

iii. Intermediate 7 Day Playing Members

Persons who have attained the age of eighteen (18) years but who are under the age of thirty-six (36) years at the time of renewal due date, and who are elected as Intermediate Playing Members or transferred by the Board from another class of Full membership to Intermediate Playing membership of the Club. Entitles members to 7-Day access to the golf course, facilities, competitions, honour board events and Golfink.

iv. Weekday Playing Members

Persons who have attained the age of eighteen (18) years who are elected as Weekday Playing Members or transferred by the Board from another class of Full membership to Weekday Playing Membership of the Club. Entitles member to 5-day access (excludes Weekends) to the golf course, facilities, competitions and Golfink.

- v. **Intermediate 6 Day Playing Members**
Persons who have attained the age of eighteen (18) years but who are under the age of thirty-six (36) years at the time of renewal due date, and who are elected as Intermediate 6 Day Playing Members or transferred by the Board from another class of Full membership to Intermediate 6 Day Playing membership of the Club. Entitles members to 6-day access (excludes Saturday) to the golf course, facilities, competitions and Golflink.

- vi. **Junior Playing Members**
Persons under the age of eighteen (18) years who are elected as Junior Playing Members or transferred by the Board from another class of Ordinary membership to Junior Playing membership of the Club. 7-Day access to the golf course, facilities, competitions, honour board events and Golflink. Valid for anyone under the age of eighteen (18) at the time of renewal due date.

- vii. **Non-Playing Members**
 - a. Any Full Playing Member, 6 Day Playing Member, Intermediate Playing Member, Country Playing Member, Weekday Playing Member, Intermediate 6 Day Playing Member, or Junior Playing Member who upon application to the Board is transferred to non-Playing membership of the Club.
 - b. Non-Playing Members may after a period of 12 months in that category be readmitted to their former category of membership on application to and at the discretion of the Board, provided that on such readmission they shall be liable for payment of any difference in subscriptions paid as a Non-Playing Member and the subscription then payable for the category of membership to which they are readmitted.

- viii. **Social Members**
Persons who have attained the age of eighteen (18) years and who are elected as Social Members of the Club.

- ix. **Special Members**
 - a. Any Full Member of the Club upon whom special membership has been conferred by the Board for services rendered to the Club. or holds or who has held a position prominent in the Club, the community or the golfing or other sporting fraternity.
 - b. Persons who are members of an affiliated golf club and whose usual place of residence is outside New South Wales, who are elected as Interstate/International Playing Members or transferred by the Board from another class of Full membership to Interstate/International Playing membership of the Club.
 - c. The Board shall have the power to cancel the membership of any Special Member without notice and without being required to give any reason.
 - d. A person elected as a Special Member shall be relieved from payment of any subscriptions or levies but shall have 7-Day access to the golf course, facilities, competitions, and Golflink.
 - e. A person elected as a Special Member shall be relieved from payment of any subscriptions or levies but shall have all the rights and privileges of 7 Day Playing Members.

x. Life Members

- a. Members who have been a financial playing Member of the Club for an aggregate of twenty five years and who have rendered outstanding volunteer service to the Club, and have been elected as such by resolution carried by at least two thirds of those present and voting at a General Meeting following the submission to such meeting of an appropriate recommendation from the Board.
- b. A Member will be eligible to be nominated for election as a Life Member if the following criteria are met:
 - (i) The Member has provided distinguished volunteer service to the Club including in areas of playing, coaching, administration (e.g sitting on committees) or general contribution (e.g fundraising, volunteering or promoting the Club); or
 - (ii) The Member has made significant contributions to the Club; or
 - (iii) The Member has exceptional achievements in the game of golf; and
 - (iv) The Member has assisted the advancement of golf in the Club or the region.
- c. A person elected as a Life Member shall be relieved from payment of any subscriptions or levies but shall have all the rights and privileges of 7 Day Playing Members.
- d. Nominated and seconded by members with minimum ten (10) years aggregate playing membership for approval by Board.

xi. Staff Members

- a. Employees of the Club who are elected as Staff Members or transferred by the Board from any other class of Full membership to Staff membership of the Club.
- b. Staff Members who cease to be employees of the Club shall forthwith cease to be Staff Members of the Club but may at the discretion of the Board be transferred to another class of Full membership of the Club.
- c. Entitles member to 7-Day access to the golf course, facilities, competitions, and Golflink.

xii. Lifestyle Members

Persons who have attained the age of eighteen (18) years who are elected as Lifestyle Playing members or transferred by the Board from another class of membership to Lifestyle Playing membership of the Club. Can play in comp and are eligible to attain a handicap. Entitles member to 7-day access to the golf course, facilities, competitions (\$45 per competition round), and Golflink. Enjoy the benefits of being a Full-Playing Member but without the commitment.

xiii. Cadet Playing Members

Persons who are elected as Cadet Golfers are under the age of thirteen (13) years who want to try golf to see whether it is a game for them. Cadets have some playing rights, although they are not members of the Club (but they are potential Junior members). Cadet Membership is perfect for juniors starting or wishing to play socially.

xiv. Non-Competition Playing Members

Persons who have attained the age of eighteen (18) years who are eligible to play on the golf course but not enter into any competitions or retain a club handicap and are elected as Non-Competition Playing Members or transferred by the Board from

another class of membership to Non-Competition Playing membership of the Club. 7 Day access to the golf course and facilities (outside of competition times).

xv. Family Playing Members

Persons who are Playing Members of any class of membership and are married or life partners living together.

(c) CONDITIONAL MEMBERS

- i. Any person who has lodged a nomination form seeking membership of the Club and pays to the Club the entrance fee (if any) plus the subscription appropriate to the class of membership referred to in the nomination form and is awaiting the decision of the Board in relation to that application.
 - ii. Conditional members shall be entitled only to the same rights and privileges as members of the category that they have applied to join.
 - iii. Conditional members shall not be entitled to attend or vote at meetings of the Club, nominate for or be elected to the Board or any office of the Club or to participate in the management, business and affairs of the Club.
- (D)** A member who resigns his or her membership of the Club and who makes application to re-join the Club within a period of no more than two (2) years from the date of resignation shall be exempted from payment of a further entrance fee.
- (E)** Any former member of the Club, having been a playing member for a period of at least five (5) years, and who makes an application to re-join the Club at any time shall be exempted from payment of any further entrance (joining) fee.
- (F) 1st YEAR APPLICATION FEES AND ANNUAL SUBSCRIPTIONS AND LEVIES**
- i. Members' subscriptions shall be paid annually or if the Board so directs and approves by instalments and in advance or for more than one year in advance. The time and manner of payment thereof and all other matters pertaining thereto not especially provided for by this Constitution shall be as prescribed by the Board from time to time.
 - ii. All online booking rights cease if payment isn't made by 30th June. Booking by calling Pro shop is available for a game if vacancies are available.
 - iii. The 1st year application fees and subscriptions or payments payable by members of the Club shall be such as the Board may from time to time prescribe provided that the annual subscription payable by Full Members shall not be less than two dollars or such other minimum subscription provided from time to time by the Registered Clubs Act.
 - iv. Any candidate elected during the membership year to any class of membership shall in respect of that membership year be entitled to reductions in subscriptions such as the Board of the Club may from time to time prescribe.
 - v. If the 1st year application fee or subscription or any part thereof of any member shall not be paid within a period of 30 days from the date upon which it shall fall due for payment, the defaulting member shall from that date be excluded from all privileges of membership and his name shall be removed from the register of members of the Club and neither the provisions of by-law 46 nor the rules of natural justice or procedural fairness shall apply to any procedure taken pursuant to this by-law.
 - vi. The Board shall have power to make charges and levies on Full Members for general and special purposes.

BOARD OF DIRECTORS

The Board shall be responsible for enforcing the Constitution and the By-laws of the Club regarding the conduct of any member or any other person on the course, and in conjunction with the General Manager, in the Clubhouse.

Names of members of the Board shall be kept posted in the Clubhouse and on the club's website.

SUB-COMMITTEES

All decisions of any Sub-Committee approved by the Board in accordance with the Constitution shall be subject to ratification, alteration or revocation by the Board. When the Board adopts a rule, policy or procedure, a Sub-Committee in following that rule, policy or procedure may subsequently report its actions to the Board for approval. A Sub-Committee shall not take any action which is at variance with a Board rule, policy or procedure without Board approval.

There shall be five standing Sub-Committees, namely:

- Finance
- Golf
- Risk
- Women's Golf
- Disciplinary

and any such other Sub-Committee as the Board shall from time to time appoint. The Board shall have power to co-opt any member or members of the Club to any such Sub-Committee whether a member of the Board or not.

All expenditure from the Club funds shall be subject to approval of the Board. The President shall be an ex-officio member of all Sub-Committees.

(A) FINANCE SUB-COMMITTEE

i. Composition:

The Finance sub-committee shall consist of the member serving as Finance Director, who shall be the Chairperson of the Finance sub-committee, the President, and two (2) other Directors elected by the Board

ii. Duties:

The Finance sub-committee shall watch generally over the control, collection and expenditure of the Club's funds and specifically shall:

- (a) keep the Board fully informed from month to month of the income and expenditure of the Club and the relationship of the income and expenditure to the approved estimates.
- (b) consider and recommend, or otherwise, any expenditure required by any sub-committee.
- (c) prepare the Annual Income and Expenditure budgets and cash flows for submission to the Board of the Club each year.

(B) GOLF SUB-COMMITTEE

i. Composition:

The Golf sub-committee shall consist of the Captain as Chairperson, and such other sub-committee members as shall be appointed by the Board of the Club.

ii. Duties:

- (a) to arrange all competition events held on the course.
- (b) to select players for all matches or competitions required for such selection.
- (c) to arrange programs of all matches and competitions, which shall be ratified by the Board of the Club.
- (d) to make and vary any Local Rules and carry out recommendations regarding preservation of the course.
- (e) to allocate trophies for all competitions on the course.
- (f) The Golf Committee shall liaise with the Director of golf to ensure that all functions related to the starting, playing and results of all competitions are carried out in a prompt and accurate manner.
- (g) to monitor the maintenance, improvements and beautification of the course and of the grounds generally, in accordance with the principles laid down by the Board of the Club.
- (h) to monitor the performance, in conjunction with the General Manager, of the Course Superintendent.
- (i) to investigate, in conjunction with the Course Superintendent and General Manager, and recommend to the Finance sub-committee, the purchase of plant, equipment, tools or materials required for course maintenance and improvements.

(C) RISK SUB-COMMITTEE

i. Composition:

The Risk sub-committee shall be comprised of a Chairperson appointed by the Board and such other sub-committee members as shall be appointed by the Board of the Club. The Chairperson shall be a Director of the Club.

ii. Duties:

- (a) to monitor any possible risk to the future well-being of the Club from both internal and external sources. This includes the activities of other local clubs, hotels and hospitality venues, government activities at all levels that may affect the Club, and any other external area that may have a detrimental effect on the Club's activities.
- (b) Responsible for the assessment of internal risk in the procedures undertaken by Club staff.
- (c) The sub-committee has wide-ranging powers to investigate any area that is deemed to fall within the preceding ambit and report its' findings to the Board, whether a risk is determined or otherwise.

(D) WOMEN'S GOLF SUB-COMMITTEE

i. Composition:

The Women's Golf Sub-committee shall consist of two (2) directors appointed by the Board, a President, Captain, Treasurer and two committee members nominated by the women golfers and approved by the Board of the Club up to a maximum of seven (7) committee members.

ii. Meetings of the Women's Golf Sub-Committee:

- (a) the Women's Golf Sub-Committee must hold a meeting in which the two (2) directors appointed by the Board to sit on the committee are in attendance at least once every three (3) months;

- (b) the Women's Golf Sub-Committee may also hold additional meetings in which the two (2) directors appointed by the Board to sit on the committee are not in attendance.
- iii. Duties:
 - (a) Once every three (3) months, the Women's Golf Sub-Committee shall provide the Board of the Club with a copy of:
 - minutes of meetings for all meetings held;
 - a report on the golfing activities completed by the Women's Golf Sub-Committee;
 during the prior three (3) months.
 - (b) To organise women's golf matches, competitions, and charity days.
 - (c) To report all proposed women's golf fixtures to the Golf Sub Committee and to obtain approval for same.
 - (d) To organise fundraising activities and events.
- iv. Income:
 - (a) All income raised by the Women's Golf Committee will be paid into the Club's general bank account.
 - (b) The Club will record the income and the Treasurer will be provided with access to the Club's accounts to allow the Treasurer to monitor payments and receipt of funds on behalf of the Women's Golf Committee.
 - (c) The sub-committee will make recommendations of proposed charitable donations proposed from the funds raised by the sub-committee to the Board for approval.

(E) DISCIPLINARY SUB-COMMITTEE

- i. Composition:

The Disciplinary sub-committee shall consist of a minimum 2 Directors, the General Manager and/or a senior staff member appointed by the Board.
- ii. Duties:
 - (a) Give written notice of any charge at least fourteen (14) days prior to the meeting at which such charge should be heard.
 - (b) Consider the evidence and representations made by the member and come to a decision as to the members guilt or innocence.
 - (c) Notify the member, at the meeting or in writing, after the meeting of the penalties imposed, if any.
 - (d) Take minutes of the proceedings.

(F) ANY OTHER SUB-COMMITTEE

REPORTS OF SUB-COMMITTEES

All reports submitted to the Board from any sub-committee shall be written or typed and circulated among the members of the Board at least 48 hours prior to the meetings of the Board at which they are to be considered.

Expenditure of the Club's funds on items other than goods for resale by the Club or on normal maintenance of the course or property shall not be incurred without prior reference to the Finance sub-committee or the General Manager which shall in respect of such reference promptly submit a report to the Board as to the ways and means.

PRINCIPAL OFFICERS OF THE CLUB

The Principal Officers of the Club and directors of the club shall be at all times bound by the contents of the board charter and shall be:

(A) THE PRESIDENT

The President shall be the Chairperson of meetings of the Board and member's General Meetings. In the absence of the President a member of the Board shall perform the duties of the President.

The President has the prime responsibility for the Club overall and for ensuring that the Board decisions are implemented.

Apart from the Chairperson's responsibility of presiding at meetings, he or she may be called upon to achieve a decision by way of an additional or casting vote where the voting of Directors reaches a non-result or equal division.

The President should be consulted in advance on any possible contentious matter relating to the Club, course or administration. This action is not to be considered a courtesy but an obligation of Directors, Administrators or Members of the Club.

The President should exercise careful supervision over the work of the General Manager and other members of the Board and ensure that decisions are promptly carried out.

The Chairperson of the meeting shall sign the recorded Minutes of the Board of Directors meetings, as confirmed by the Board and Minutes of General Meetings as confirmed by the members.

(B) THE CAPTAIN

The Captain shall have a sound knowledge of the Rules of Golf and will ensure that all competitions are played in accordance with those Rules. In the absence of the Captain, the person so nominated shall perform the duties of the Captain.

(C) THE FINANCE DIRECTOR

The Finance Director shall supervise the financial affairs of the Club and shall advise the Board on all matters relating to the financial aspects of the Club's operations.

(D) THE GENERAL MANAGER

The General Manager shall be the Secretary of the Club, in accordance with the Registered Clubs Act.

He/she shall keep upon the Club premises a Register of Members and a Register of Guests as required by the Constitution of the Club and the Registered Clubs Act. He/she shall keep full and correct Minutes of all resolutions and proceedings at meetings of the Club and the Board, produce them at all meetings of the Club and the Board. He/she shall keep such books and records as are required by the Club's Constitution, the Companies Act and the Registered Clubs Act and shall attend to the filing of such returns and documents as are required to be filed with any regulatory body.

The General Manager shall receive and pay into such bank as the Board may from time to time direct, such monies as come into his/her hands on behalf of the Club and record the entries in respect thereof in the books of the Club.

In the day to day running of the routine affairs of the Club the General Manager shall report directly to the President and in his/her absence to the Finance Director.

The General Manager should be responsible to ensure that details of meetings internal and external are recorded and filed appropriately.

The General Manager shall be present at the Finance Sub-Committee meetings and such other meetings of the Board as are deemed necessary.

The General Manager will be authorized to expend up to \$10,000 for Capital Expenditure and report such expenditure to the Finance Sub-Committee of the club.

The General Manager will be authorized to spend up to \$15,000 for Capital Expenditure with the approval of the President or Finance Director.

MANAGEMENT OF THE CLUB

Decisions of the Board of the Club and any directives or policy shall be conveyed by the President. All instructions of the Board of the Club shall be transmitted to all relevant parties through the General Manager.

All complaints or requests from staff shall be made to the General Manager, President, Captain or Finance Director according to the circumstances.

No member of the Board of the Club shall directly instruct or reprimand any employee of the Club.

USE OF THE COURSE AND CLUBHOUSE

The Board may at its discretion impose restrictions on the use of the course or the clubhouse by any members, class of members or visitors for any period and may suspend or remove such restrictions for any period.

CLUBHOUSE RULES

(A) SERVICE

Service areas of the Club, including bars and kitchens, may be entered only by staff of the Club

(B) TRADING HOURS

The clubhouse will be open at such hours and for such periods as the Board of the Club shall determine from time to time.

(C) VACATING PREMISES

Members, guests and visitors must vacate the premises in accordance with the rules and requirements of the Board of the Club having regard to the hours of trading laid down

(D) CHILDREN

- i. No person under the age of eighteen (18) years shall be allowed in the area of any bar in the clubhouse or enter the Poker Machine Room.
- ii. No person under the age of Eighteen (18) years shall be allowed to partake of intoxicating refreshments at any time whilst on any part of the Club premises.

(E) DRESS REGULATIONS

- i. Members, guests and visitors must be suitably attired when on the course and in the clubhouse.
- ii. Footwear must be worn at all times on the course and in the clubhouse and must be as prescribed by the Board of the Club from time to time.
- iii. Spiked shoes must not be worn on the golf course or in the clubhouse.

- iv. Long socks and short sports socks may be worn with shorts on the course and in the clubhouse.
- v. Golf attire will be acceptable in the clubhouse at all times unless otherwise laid down by the Board of the Club.

(F) GAMES

Playing of any games in the clubhouse is permitted only in accordance with conditions laid down by the Board from time to time.

(G) COLLECTIONS

No collections, for charity or otherwise, or sale of tickets or soliciting for contributions shall be made in the clubhouse or on the course without sanction of the General Manager or senior employee on duty, nor shall any lottery or raffle be conducted thereon without such sanction.

(H) NOTICES

No notices or paper, written or printed, shall be posted in or about the clubhouse or on the course unless approved by the General Manager of the Club or otherwise by authority of the Board of the Club and no member may remove any such notice or paper once it is posted.

(I) ADVERTISING

No advertising or advertising matter of any kind may be displayed or exhibited on the Club's property except with the approval of the General Manager of the Club or with permission of the Board of the Club.

(J) ANIMALS

Dogs, cats and other pets, other than registered companion animals, are not permitted on the course or in the clubhouse.

(K) COMPLAINTS

Any complaints of a member, guest or visitor shall be lodged with the General Manager, who may deal summarily therewith. If the matter is one in which a summary decision or action cannot be taken, the member, guest or visitor shall submit a complaint in writing for decision by the Board of the Club.

(L) SUGGESTIONS

Any member, guest or visitor wishing to make a suggestion regarding any aspect of the Club affairs shall submit such suggestion in writing to the General Manager. Suggestions will be considered by the Board of the Club at its next meeting and the member advised of the decision of the Board regarding the suggestion.

COURSE RULES

(A) COMMENCEMENT OF PLAY

Members and their guests are not to commence play on the golf course without the permission of the starter of the day or the Club's Professional or his representative.

(B) BUGGIES

Only buggies with wide wheels are allowed on the course.

(C) SAND BUCKETS

Players are required to carry a sand bucket at all times and to repair divots.

(D) RUBBISH

All members and their guests are required to place empty cans and bottles and other forms of litter in the bins provided.

(E) GREENS STAFF

Greens staff have right of way on the golf course at all times.

(F) TIME OF ROUND

Members and their guests should complete a competition round in a maximum time of 2 hours and 15 minutes for 9 holes and 4 hours and 20 minutes and finish no more than 15 minutes behind the group in front for 18 holes.

(G) DRESS ON THE COURSE

Players shall always be well and suitably attired in accordance with the guidelines laid down by the Board of the Club from time to time.

ETIQUETTE AND CONDUCT OF PLAY

The player on the lowest handicap in any match shall act as Captain of the Match for the purpose of ensuring that the etiquette of Golf is observed by all members of the match particularly in regard to the time taken for the Match to complete its game and to the "call through" rules. Should two (2) or more players be equally handicapped they should decide among themselves who shall act as the Captain of the Match.

Any member or visitor who has occasion to complain about the conduct of another member or any player must lodge his or her complaint with the General Manager or Direct of Golf, in writing.

No member or visitor shall remove from the clubhouse or grounds, or damage, the property of the Club. Any member or visitor damaging or removing any property of the Club shall, in addition to such penalty as may be imposed upon him or her by the Board of the Club, make good any property removed and any such damage or pay for same to the satisfaction of the Board of the Club.

Any player who, in the opinion of any member of the Board, the General Manager or the starter is affected by alcohol shall not be permitted to play or continue to play on the course while so affected. Any member or visitor of the Club who is affected by alcohol during play shall be guilty of a breach of this By-Law and may be dealt with pursuant to the Constitution of the Club.

Members and visitors must abide by all directions shown on notices and signs regarding routes to be followed on the golf course.

Player's Code of Conduct is the guiding document for players conduct on the course.

MATCH RULES

(A) TEE TIMES

- i. Players must report to the starter of the day at least fifteen (15) minutes prior to their tee time.
- ii. Any player cancelling or not arriving for their nominated tee time is ineligible to play in that day's competition at another time, unless approved by the Captain or his representative.

(B) DUTIES OF MARKERS

Markers should observe conscientiously their obligations under the Rules of Golf regarding the scoring and completing of cards and interpretation of the Rules of Golf.

(C) CARDS

Immediately on completion of the round, all scores, even if incomplete, must be entered into the computer system, if using a card, or submitted electronically via the approved app.

(D) INTERPRETATION OF THE RULES

Should any player or marker be in doubt concerning the application of a Rule of Golf or Local Rule to a particular incident in the course of competition play he or she must immediately on returning to the clubhouse report the facts to the Captain, or his representative, or the General Manager (in writing if required) so a ruling can be given by the Golf Sub-Committee. In such cases cards must not be signed or scores submitted electronically until a ruling is given. Players should make themselves familiar with the Rules of Golf covering disputes or doubt as to procedures.

(E) PROTESTS

Any protest in connection with play shall be delivered in writing to the Captain, or his representative, or the General Manager immediately after completion of the match or round. Such a protest shall be dealt with by the Golf sub-committee according to the Rules of Golf as soon as possible.

(F) RULES - LOCAL/GOLF

It is the duty of each member to ascertain what Local Rules apply before the commencement of the round and to understand and observe the Rules of Golf.

(G) CONDITIONAL MEMBERS, 6 DAY MEMBERS AND WEEKDAY MEMBERS

The playing rights of Conditional members, 6 Day members and Weekday members are laid down by the Board of the Club from time to time. Conditional members, 6 Day members and Weekday members may not play in any competition, nor at any time, not authorised by the Board of the Club

(H) TROPHIES

The Golf sub-committee shall decide the allocation of trophies for all competitions and its decision shall be final. Approved by Finance Committee on an annual basis.

(I) ALTERATIONS TO HANDICAPS

The Board of Directors may from time to time approve the alteration of a member's handicap if in its absolute discretion and having regard to all of the circumstances including the member's results in any form of competition, it considers that the change is warranted under the handicap system which the club follows. The member shall have no right to make any representations to the Captain or to the Board of Directors in relation to any proposed alteration of a member's handicap

GAMING MACHINES

Members and guests must observe the gaming regulations displayed in the gaming area.

MOTORISED GOLF CARTS AND MOTOR BIKES

(A) Members wishing to use their own motorised golf cart or motor bike on the Course must apply in writing to the Board of the Club and must not use it on the Course until inspected for suitability for use on the course by the appropriate person nominated by the Board of the Club and approved for use on the course by the Board of the Club.

(B) Motorised golf carts and motor bikes:

- i. must not be driven onto tees or greens or between bunkers and greens.
- ii. must not be driven or left within ten (10) metres of greens.
- iii. must obey all blue line markings, signifying no carts beyond this line around greens.

- iv. must be parked at the sides of greens whilst putting and are not to be left unattended in front of any green.
- v. must not be used on the course except whilst playing a round of golf or in carrying out Club activities.
- vi. must not be used when the course is suffering severe wet weather conditions, at the direction of the Captain, the Course Superintendent or the General Manager or their nominees.
- vii. Players using motorised golf carts and motorbikes must maintain their normal place in the field and shall have no special priority.
- viii. Players using motorised golf carts and motor bikes must ensure that use of such does not interfere with or distract other players on the golf course.
- ix. Users of private motorised golf carts and motorbikes must ensure that all necessary registration and insurances are in place and if required to do so furnish a copy of such registration and insurances to the General Manager.
- x. Users of private motorised golf carts and motor bikes must pay an annual fee for using the cart or bike on the golf course and storage, if applicable, determined by the Board from time to time. This fee is due on 1st July each year and payable no later than 30 days from the due date.
- xi. The Board of the Club may limit the competitions in which motorised golf carts and motorbikes may be used.
- xii. All private golf cart use will cease as at 30th June 2028.
